"The NACC-Central Office (CO) shall pay the Services Provider on a semi-monthly basis, cut off period every 15th and 30th of the month, within 10 days upon receipt of the SOA or billing statement of a given period, duly certified true and correct semi-monthly report and/ or Proof of Deliveries (PODs) or other forms of verification that the recipients have received their packages and a Certificate of Satisfactory Service rendered for complete deliveries issued by the NACC.


